THIS PRIVACY POLICY DESCRIBES HOW NORMAN'S CAFE (THE "SITE" OR "WE") COLLECTS, USES, AND DISCLOSES YOUR PERSONAL INFORMATION WHEN YOU VISIT OR MAKE A PURCHASE FROM THE SITE.

COLLECTING PERSONAL INFORMATION

WHEN YOU VISIT THE SITE, WE COLLECT CERTAIN INFORMATION ABOUT YOUR DEVICE, YOUR INTERACTION WITH THE SITE, AND INFORMATION NECESSARY TO PROCESS YOUR PURCHASES. WE MAY ALSO COLLECT ADDITIONAL INFORMATION IF YOU CONTACT US FOR CUSTOMER SUPPORT. IN THIS PRIVACY POLICY, WE REFER TO ANY INFORMATION THAT CAN UNIQUELY IDENTIFY AN INDIVIDUAL (INCLUDING THE INFORMATION BELOW) AS "PERSONAL INFORMATION". DEVICE INFORMATION

EXAMPLES OF PERSONAL INFORMATION COLLECTED: VERSION OF WEB BROWSER, IP ADDRESS, TIME ZONE, COOKIE INFORMATION, WHAT SITES OR PRODUCTS YOU VIEW, SEARCH TERMS, AND HOW YOU INTERACT WITH THE SITE. - PURPOSE OF COLLECTION: TO LOAD THE SITE ACCURATELY FOR YOU, AND TO PERFORM ANALYTICS ON SITE USAGE TO OPTIMIZE OUR SITE. - SOURCE OF COLLECTION: COLLECTED AUTOMATICALLY WHEN YOU ACCESS OUR SITE USING COOKIES, LOG FILES, WEB BEACONS, TAGS, OR PIXELS - DISCLOSURE FOR A BUSINESS PURPOSE: SHARED WITH OUR PROCESSORS SHOPIFY & PAYPAL

ORDER INFORMATION

USING PERSONAL INFORMATION

WE USE YOUR PERSONAL INFORMATION TO PROVIDE OUR SERVICES TO
YOU, WHICH INCLUDES:
OFFERING PRODUCTS FOR SALE, PROCESSING PAYMENTS, SHIPPING AND
FULFILMENT OF YOUR ORDER,
AND KEEPING YOU UP TO DATE ON NEW PRODUCTS, SERVICES, AND
OFFERS.

LAWFUL BASIS

PURSUANT TO THE GENERAL DATA PROTECTION REGULATION ("GDPR"), IF YOU ARE
A RESIDENT OF THE EUROPEAN ECONOMIC AREA ("EEA"), WE PROCESS YOUR
PERSONAL INFORMATION UNDER THE FOLLOWING LAWFUL BASES:
YOUR CONSENT; IN SOME CASES, WE MAY RELY ON YOUR CONSENT TO PROCESS
PERSONAL DATA. WHERE WE RELY ON CONSENT, YOU HAVE THE RIGHT TO
WITHDRAW YOUR CONSENT AT ANY TIME. PLEASE NOTE THAT WITHDRAWAL OF
CONSENT DOES NOT AFFECT THE LAWFULNESS OF PROCESSING BASED ON
CONSENT BEFORE ITS WITHDRAWAL. THE PERFORMANCE OF THE CONTRACT
BETWEEN YOU AND THE SITE; WE PROCESS PERSONAL DATA TO FULFILL OUR
CONTRACTUAL OBLIGATIONS AND PROVIDE THE SERVICES REQUESTED BY OUR
CUSTOMERS. THIS INCLUDES PROCESSING PERSONAL DATA NECESSARY FOR THE
MANAGEMENT OF ORDERS, DELIVERY OF PRODUCTS, AND CUSTOMER SUPPORT.
LEGAL OBLIGATION; WE MAY PROCESS PERSONAL DATA TO COMPLY WITH LEGAL
OBLIGATIONS TO WHICH WE ARE SUBJECT, SUCH AS TAX OR ACCOUNTING
REQUIREMENTS, OR TO RESPOND TO LAWFUL REQUESTS BY PUBLIC AUTHORITIES.
LEGITIMATE INTERESTS; WE MAY PROCESS PERSONAL DATA TO COMPLY WITH
LEGAL OBLIGATIONS TO WHICH WE ARE SUBJECT, SUCH AS TAX OR ACCOUNTING
REQUIREMENTS, OR TO RESPOND TO LAWFUL REQUESTS BY PUBLIC AUTHORITIES.
WE ENSURE THAT THE PROCESSING OF PERSONAL DATA IS ALWAYS
PROPORTIONATE TO THE PURPOSES FOR WHICH IT IS CARRIED OUT, AND THAT
INDIVIDUALS' RIGHTS ARE RESPECTED AT ALL TIMES.

RETENTION

WHEN YOU PLACE AN ORDER THROUGH THE SITE, WE WILL RETAIN YOUR PERSONAL INFORMATION FOR OUR RECORDS FOR AS LONG AS IS NECESSARY UNTIL YOU ASK US TO ERASE THIS INFORMATION. FOR MORE INFORMATION ON YOUR RIGHT OF ERASURE, PLEASE SEE THE 'YOUR RIGHTS 'SECTION BELOW.

AUTOMATED DECISION-MAKING

IF YOU ARE A RESIDENT OF THE EEA, YOU HAVE THE RIGHT TO OBJECT TO PROCESSING BASED SOLELY ON AUTOMATED DECISION-MAKING (WHICH INCLUDES PROFILING), WHEN THAT DECISION-MAKING HAS A LEGAL EFFECT ON YOU OR OTHERWISE SIGNIFICANTLY AFFECTS YOU. WE DO NOT ENGAGE IN FULLY AUTOMATED DECISION-MAKING THAT HAS A LEGAL OR OTHERWISE SIGNIFICANT EFFECT USING CUSTOMER DATA. OUR PROCESSOR SHOPIFY USES LIMITED AUTOMATED DECISION-MAKING TO PREVENT FRAUD THAT DOES NOT HAVE A LEGAL OR OTHERWISE SIGNIFICANT EFFECT ON YOU. SERVICES THAT INCLUDE ELEMENTS OF AUTOMATED DECISION-MAKING

INCLUDE:

- TEMPORARY DENYLIST OF IP ADDRESSES ASSOCIATED WITH REPEATED FAILED TRANSACTIONS.
THIS DENYLIST PERSISTS FOR A SMALL NUMBER OF HOURS.
- TEMPORARY DENYLIST OF CREDIT CARDS ASSOCIATED WITH DENYLISTED IP ADDRESSES. THIS
DENYLIST PERSISTS FOR A SMALL NUMBER OF DAYS.

YOUR RIGHTS - GDPR

IF YOU ARE A RESIDENT OF THE EEA, YOU HAVE THE RIGHT TO ACCESS THE PERSONAL INFORMATION WE HOLD ABOUT YOU, TO PORT IT TO A NEW SERVICE, AND TO ASK THAT YOUR PERSONAL INFORMATION BE CORRECTED, UPDATED, OR ERASED.
